On March 29, 2023, Cincinnati Bell Extended Territories LLC d/b/a altafiber connected services, pursuant to Section 392.550, RSMo, filed an application for registration to provide Basic Local Exchange (CLEC) Telecommunications Services in the following exchanges:

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo.
