**APPLICATION OF
CABLE & WIRELESS GLOBAL CARDS SERVICES, INC.
TO CANCEL ITS CERTIFICATE OF SERVICE AUTHORITY AND TARIFFS**

COMES NOW Cable & Wireless Global Cards Services, Inc. ("C & W Card Services") by and through its attorney and, pursuant to Section 392.410.5, RSMo 2000, respectfully requests the Missouri Public Service Commission ("Commission") to cancel its Certificate of Service Authority and Tariffs. In support of its Application, C & W Card Services states as follows:

1. C & W Card Services is a certificated interexchange carrier in Missouri with its principal place of business located at 8219 Leesburg Pike, Room, Vienna, Virginia 22182. C & W Card Services, a Delaware corporation, was authorized on July 31, 1998, in Case No. TA-98-566, to offer, render, furnish or supply interexchange telecommunication services as a reseller to the public within the state of Missouri. C & W Card Services' Certificate to Transact Business as a Foreign Corporation was filed in that docket and is incorporated herein by reference.

2. Due to a change in business plans, which will no longer include the prepaid or the postpaid calling card market, C & W Card Services requests the Commission to cancel its Certificate

of Service Authority and Tariffs since C & W Card Services has no existing customers on these services and has generated no revenue for over a year within this market. Accordingly, C & W Card Services does not have to notify anyone regarding discontinuance of service in Missouri.




