## ORDER DIRECTING STAFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On March 14, 2022, Union Electric Company d/b/a Ameren Missouri filed a revised tariff sheet designed to maintain consistency with revised MISO Load Modifying Resource (LMR) requirements. According to Ameren Missouri, the change will allow its Business Demand Response Program to continue to receive the full benefit of counting Business Demand Response (DR) as LMR. The revised tariff sheet has an April 13, 2022 effective date.

The Commission will set a time for responses or objections to the revised tariff sheet and direct its Staff to file a recommendation.

### THE COMMISSION ORDERS THAT:

1. No later than March 25, 2022, the Staff of the Commission shall file a recommendation regarding Ameren Missouri's tariff sheet set out in Tracking No. YE-2022-0238.

2. Any other responses or objections to Ameren Missouri's tariff sheets, Tracking No. YE-2022-0238, shall be filed no later than March 25, 2022.

3. This order is effective when issued.
