**ORDER GRANTING INTERVENTIONS**

On June 19, 2018, the Commission held a procedural conference in this matter. At the procedural conference, Union Electric Company d/b/a Ameren Missouri stated that it had no objection to the outstanding interventions of the Consumers Council of Missouri, the Natural Resources Defense Council, Kansas City Power & Light Company, KCP&L Greater Missouri Operations Company, and Spire Missouri Inc. being granted. Those parties all filed timely applications to intervene and no party objected to the interventions.

The Regulatory Law Judge granted those interventions at the procedural conference and further confirms that grant with this order. The Commission finds that allowing each of these organizations to intervene will serve the public interest. Therefore, in accordance with Commission Rule 4 CSR 240-2.075(3), the Commission grants the applications to intervene.

**THE COMMISSION ORDERS THAT:**

1. The application to intervene of the Consumers Council of Missouri, the Natural Resources Defense Council, Kansas City Power & Light Company, KCP&L Greater Missouri Operations Company, and Spire Missouri Inc. are granted.
