On March 16, 2016, The Empire District Electric Company, Liberty Utilities (Central) Co. and Liberty Sub Corp. ("Joint Applicants") filed a joint application asking the Commission to approve a merger transaction. On August 25, 2016, Joint Applicants filed a pleading stating that there are no remaining disputed issues to resolve in this matter, other than stipulations and agreements that purport to resolve all outstanding issues regarding the proposed transaction. Since there are no issues to be addressed at an evidentiary hearing, the Commission will cancel the evidentiary hearing scheduled to begin on August 29, 2016. The Commission would like to question the parties about the pending stipulations and agreements and will schedule an on-the-record proceeding for that purpose. The Commissioners anticipate having questions only about the stipulations and agreements between Joint Applicants and the Office of the Public Counsel, Staff, and Division of Energy/Renew Missouri.

THE COMMISSION ORDERS THAT:

1. The evidentiary hearing scheduled for August 29-31, 2016, is canceled.

2. An on-the-record proceeding for the purpose of questioning the parties about the proposed stipulations and agreements is scheduled for Tuesday August 30, 2016 beginning at 10:00 a.m., at the Commission's office at the Governor Office Building, Room 305, 200 Madison Street, Jefferson City, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act.
