ORDER DENYING MOTION FOR INTERVENTION

The Commission is denying the *Application to Intervene and Motion for Expedited Treatment* (“motion”)¹ of Midwest Energy Consumers Group (“MECG”). The Commission’s regulation on intervention allows for MECG to intervene under two conditions: either MECG:

- (A) . . . has an interest which is different from that of the general public and which may be adversely affected by a final order arising from the case; or
- (B) Granting the proposed intervention would serve the public interest. [²]

MECG suggests that its intervention “will serve the public interest by assisting the record for the Commission’s decision in this case.”

This file includes no record, will result in no decision, and does not constitute a “case” in the sense of adjudicating Great Plains Energy, Inc.'s acquisition of Westar Energy, Inc. This file simply assists Staff in conducting its investigation. The Commission will deny the motion. If a complaint, application, or other action to adjudicate that transaction comes before the Commission, MECG may be able to show grounds for intervention in such action.
