ORDER GRANTING SECOND MOTION FOR EXTENSION

On June 11, 2021, Union Electric Company d/b/a Ameren Missouri filed an application to lease fiber capacity to MCC Network Services, LLC. The Commission ordered the Staff of the Commission to file a recommendation no later than July 14, 2021.

On July 14, 2021, the Staff of the Commission filed a Motion for Extension. Staff stated that it had data requests pending, and that it could file its recommendation by September 13, 2021. The Commission granted the motion.

On September 10, 2021, Staff filed its Second Motion for Extension. Staff received responses to a data request on September 9, 2021. Staff wishes to incorporate this new information into its recommendation. As such, Staff asks for an extension of time until September 22, 2021. Ameren Missouri does not object.

The Commission finds the motion reasonable, and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's second motion for extension of time is granted.

2. The Staff of the Commission shall file a recommendation no later than September 22, 2021.

3. This order shall be effective when issued.
