ORDER GRANTING APPLICATION TO INTERVENE

On April 19, 2022, Union Electric Company d/b/a Ameren Missouri filed an application requesting Commission approval to transfer an undivided 49% interest in certain transmission facilities in, around, and near the City of Hannibal, Missouri. Ameren Missouri seeks to transfer these facilities to the Missouri Joint Municipal Electric Utility Commission d/b/a Missouri Electric Commission (MEC). The Commission provided notice of Ameren Missouri's application and set a deadline for applications to intervene.

On May 19, 2022, MEC timely filed an application to intervene. MEC stated that it is an incorporated entity organized on a state-wide basis to promote efficient arrangements to meet the power and energy requirements of the municipal electric utilities in Missouri. MEC stated its interests are different than those of the general public as it has a direct and immediate interest in this case. MEC stated that it supports Ameren Missouri's application.

More than ten days have passed since the filing of MEC's application to intervene and no one has responded.¹ After considering the unopposed application to intervene, the Commission finds that MEC has interests which are different from that of the general

public. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

1. MEC's application to intervene is granted
2. This order shall be effective when issued.
