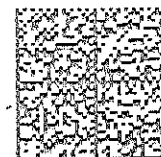

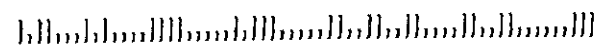

On November 9, 2010, Osage Valley Electric Cooperative ("Osage") submitted to the Commission an Application for Change of Electrical Power Suppliers. Osage wants to transfer four customers from Osage to Kansas City Power & Light Company ("KCP&L").


