ORDER GRANTING AUTOMATIC INTERVENTION AND TREATING NON-DISCLOSURE AGREEMENTS AS IF FILED IN THIS CASE

Union Electric Company, d/b/a Ameren Missouri, filed a motion on February 23, 2011, asking the Commission to open a case in which the company intends to file its 2011 Integrated Resource Plan. Ameren Missouri explains that it has previously obtained waivers relating to this filing in another case, File No. EE-2010-0243. The Commission allowed several parties to intervene in that case. In addition, several parties filed either Non-Disclosure Agreements or Certificates of Compliance in that case to enable their consultants to review highly confidential information. So that it can expedite its ability to provide highly confidential information to those parties in this new case, Ameren Missouri asks the Commission to make the parties to File No. EE-2010-0243 parties to this case without requiring those parties to again apply to intervene. Ameren Missouri also asks the Commission to order that all Non-Disclosure Agreements and Certificates of Compliance filed in File No. EE-2010-0243 be treated as if they were filed in this new case.

Ameren Missouri's request will allow parties to the earlier waiver case to immediately participate in this case and will allow the company to promptly supply those parties with the highly confidential portions of its Integrated Resource Plan while still protecting the confidentiality of those documents. For those reasons, the Commission will grant Ameren

Missouri's request. Once Ameren Missouri has filed its Integrated Resource Plan in this case, the Commission will take the appropriate steps to provide notice of the filing and offer an opportunity for additional parties to intervene.

THE COMMISSION ORDERS THAT:

- 1. All parties to File No. EE-2010-0243 are made parties to this case with no need to apply to intervene.
- All Non-Disclosure Agreements and Certificates of Compliance filed in File
 No. EE-2010-0243 shall be treated as if they were filed in this case.
- 3. The Commission's Data Center shall provide a copy of this order to all parties in File No. EE-2010-0243.
 - 4. This order shall become effective immediately upon issuance.
