ORDER ESTABLISHING A PROCEDURAL SCHEDULE

As required to do by Commission Rule 4 CSR 240-20.100(7)(B), each of Missouri's four investor-owned electric utilities has filed a Renewable Energy Standard Compliance Plan for 2011-2013. Several parties filed comments regarding some or all of those plans, including allegations that the plans are deficient in some respects. On August 4, 2011, the Commission conducted a conference regarding the plans submitted by each of the electric utilities. At that conference, the presiding officer directed the parties to file their recommendations regarding how the Commission should proceed.

On August 10, Ameren Missouri, The Empire District Electric Company, KCP&L, KCPL-GMO, Renew Missouri, the Commission's Staff, and MIEC filed a joint recommendation. Those parties agree that an evidentiary hearing is not necessary. They

also indicate that the issues in the four cases overlap and recommend that the Commission address all four reports in a single proceeding.

The Commission will accept the recommendation of the parties.

THE COMMISSION ORDERS THAT:

1. Any party that wishes to file an additional response to Renew Missouri's comments shall do so no later than August 11, 2011.

2. Renew Missouri shall file its reply to the responses of the other parties no later than August 22, 2011.

3. Oral argument regarding the RES compliance plans of each of the four electric utilities and the comments submitted by the other parties will be held on August 30, 2011 at 1:30 p.m., at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 310. This building meets accessibility standards required by the Americans with Disabilities Act. 4. This order shall become effective immediately upon issuance.
