On July 19, 2021, the Staff of the Commission (Staff) filed its recommendation that the Commission approve Evergy Missouri Metro and Evergy Missouri West's (collectively "Evergy") Pay As You Save® (PAYS®) pilot program tariff sheets with modifications. Staff asks that the Commission 1) issue an order rejecting Evergy's earnings opportunities; and 2) order Evergy to meet with the parties in order to reach an agreed upon earnings opportunity as required by the Commission's Amended Report and Order in this case.

The Commission will direct Evergy to respond.

### THE COMMISSION ORDERS THAT:

1. No later than July 28, 2021, Evergy shall respond to Staff's Recommendation and Memorandum.
2. This order is effective when issued.
