ORDER DIRECTING STAFF RECOMMENDATION

On December 16, 2022, the Commission's Staff (Staff) filed its recommendation to approve Evergy Missouri Metro and Evergy Missouri West's (collectively "Evergy") tariff sheets corresponding to Tracking Nos. YE-2023-0109 and YE-2023-0111. The Commission's December 13, 2022 order also directed Staff to file a recommendation about Tracking No. YE-2023-0110, which Staff's recommendation did not address. The Commission will direct Staff to file a recommendation about Evergy's tariff revision bearing Tracking No. YE-2023-0110.

Staff also recommends that Evergy's tariff revisions take effect on January 11, 2023, and January 12, 2023. Evergy has requested that those tariff sheets take effect on January 1, 2023, to avoid any gaps in Missouri Energy Efficiency Investment Act Cycle 3 programs. The Commission will direct Staff to address Evergy's request to expedite the tariff's effective dates.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation about Tracking No. YE-2023-0110 no later than December 20, 2022, at noon.

2. Staff shall file a recommendation about Evergy's request for expedited treatment no later than December 20, 2022, at noon.

3. This order is effective when issued.
