ORDER ESTABLISHING TIME TO RESPOND

On December 12, 2022, Evergy Metro, Inc. d/b/a Evergy Missouri Metro ("EMM") and Evergy Missouri West, Inc. d/b/a Evergy Missouri West ("EMW") filed tariff sheets (Tracking Nos. YE-2023-0109 and YE-2023-0110) with an effective date of January 11, 2023. The tariff sheets were meant to extend certain MEEIA 3 programs until December 31, 2023, for the EMM service area. Also on December 12, 2022, EMM and EMW filed a motion asking the Commission to expedite its approval of the tariff sheets so that they can go into effect on January 1, 2023, thereby avoiding a gap in the availability of MEEIA 3 programs.

On December 13, 2022, EMM and EMW filed additional tariff sheets (Tracking No. YE-2023-0111) with an effective date of January 12, 2023, for the EMW service area. A second motion for expedited treatment was also filed asking that, for the same reason, the EMW tariff sheets also go into effect on January 1, 2023. EMW explained that it had intended to file these tariff sheets with the EMM tariff sheets but had inadvertently failed to file them.

The Commission directed Staff to file an expedited recommendation regarding the tariff sheets and established a date by which any other party may respond to those tariff

sheets. The Commission will also order an expedited recommendation regarding the latest filing, Tracking No. YE-2023-0111.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendations regarding the tariffs filed by EMM and EMW (Tracking No. YE-2023-0111) no later than December 16, 2022.
2. Any other party wishing to respond to the tariff sheets filed by EMM and EMW (Tracking No. YE-2023-0111) shall do so no later than December 16, 2022.
3. This order shall be effective when issued.
