The Commission opened this file on August 12, 2020, at its Staff's request to facilitate Staff's investigation into an agreement between Evergy, Inc. and Elliott Management Corporation. On December 8, 2021, the Commission directed Evergy to submit quarterly status reports on March 1, June 1, September 1, and December 1, 2022.

In its June 1, 2022, quarterly status report, Evergy requested that it be relieved of its obligation to file additional quarterly reports. The Commission will direct Staff to respond to that request, and will set a deadline for other parties to respond.

## THE COMMISSION ORDERS THAT:

1. No later than July 13, 2022, Staff shall respond to Evergy's request to be relieved of its obligation to file quarterly status reports.

2. Any other party wishing to respond to Evergy's request to be relieved of its obligation to file quarterly status reports shall do so no later than July 13, 2022.
