The Commission opened this file on August 12, 2020, at its Staff's request to facilitate Staff's investigation into an agreement between Evergy, Inc. and Elliott Management Corporation. Staff filed a report regarding its investigation on February 26, 2021. In response to that report, the Commission directed Evergy to file quarterly status reports regarding material changes to its Sustainability Transformation Plan.

In its most recent quarterly report, filed on June 1, 2022, Evergy asked to be relieved of the obligation to file additional quarterly reports. On July 13, Staff filed a pleading indicating it does not object to Evergy's request to cease filing the reports.
