DEADLINE, AND DIRECTING RESPONSE**

On January 4, 2023, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively “Evergy”) filed a request asking the Commission to grant it a variance from 20 CSR 4240-22.080. Specifically, Evergy seeks to delay its next required annual resource plan update filing from March 2023, until June 15, 2023.

The Commission will provide notice to potentially interested parties, and will establish an intervention deadline. The Commission will also direct its Staff to file a recommendation about Evergy’s variance request.

**THE COMMISSION ORDERS THAT:**

1. The Commission’s Data Center shall provide a copy of this order to all parties to Evergy’s most recent integrated resource plan dockets, File Nos. EO-2022-0201 and EO-2022-0202.

2. Any proper person wishing to intervene in this matter shall file an application to do so no later than January 23, 2023.

3. Staff shall file its recommendation or a status report about Evergy's request no later than January 27, 2023.

4. This order is effective when issued.
