On April 14, 2023, The Empire District Electric Company d/b/a Liberty filed its 2022 Renewable Energy Standard (RES) Compliance Report (Report) and 2023 RES Compliance Plan (Plan). The Commission ordered its Staff (Staff) to review the Report and Plan and to file a report on May 30, 2023. On May 26, 2023, Staff filed a motion requesting an extension of time to file its recommendation to June 23, 2023. In its motion, Staff explained that it required additional time to review Liberty's filings. Staff's motion states that Liberty does not oppose an extension.

The Commission finds Staff's request reasonable and will order Staff to file its recommendation no later than June 23, 2023.
