On April 17, 2023, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (Evergy Metro) filed its 2022 Renewable Energy Standard (RES) Compliance Report and its 2023 Annual RES Standard Compliance Plan, as required by Commission Rule 20 CSR 4240-20.100(8).

On May 1, 2023, the Missouri Department of Natural Resources, Division of Energy, filed a timely application to intervene.

More than ten days have passed since the application to intervene was filed and no one has filed an objection to it. After considering the unopposed application to intervene, the Commission finds that the Division of Energy has a statutory role in certifying renewable energy resources, pursuant to Section 393.1030.4, RSMo – an interest that is different from that of the general public. Allowing the Division of Energy to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the Division of Energy's application to intervene.

THE COMMISSION ORDERS THAT:

1. The application to intervene of the Missouri Department of Natural

Resources, Division of Energy, is granted.

2. This order shall be effective when issued.
