The Staff of the Commission (Staff) filed a status report on July 31, 2023. Staff’s status report explained that Staff has been conducting discovery in order to complete its audit and prepare a recommendation. Staff also anticipates conducting follow up discovery. Staff asked that it be allowed until September 15, 2023, to file its recommendation and report. Staff also suggests that the time for responses to its recommendation and report be extended to September 29, 2023. The Commission will grant Staff’s request.

THE COMMISSION ORDERS THAT:

1. Staff must file its recommendation and report no later than September 15, 2023.
2. Any responses to Staff’s recommendation and report shall be filed no later than September 29, 2023.
