**COMES NOW** Timber Creek Sewer Company (Timber Creek), and, in response to the *Corrected Staff Recommendation*, states as follows to the Missouri Public Service Commission (Commission):

1. On July 10, 2018, Timber Creek filed an application seeking a certificate of convenience and necessity to provide sewer service in an area of Clay County, Missouri, adjacent to Tiber Creek’s existing service area.

2. On September 6, 2018, the Staff of the Commission (Staff) filed a *Staff Recommendation* and an associated Memorandum. A *Corrected Staff Recommendation* was filed on September 7, 2018. The *Corrected Staff Recommendation* recommends approval of the application, as described in Memorandum items 1-3 (Memo, p. 5 of 5)

3. Timber Creek has no objection to the *Corrected Staff Recommendation*.




