- 3. The MIEC and its members do not yet have a position on the issues in this case and reserve the right to take positions on specific issues as this case proceeds.

4. Intervention by the MIEC and its members will serve the public interest by assisting the Commission's record for decision in this case.

WHEREFORE, the MIEC requests that it be permitted to intervene and be made a party to this case for all purposes.
