Re: Request of Nextlink Wireless, LLC for Cancellation  
of its Telecommunications Authorization and Tariff

Dear Mr. Woodruff:

Nextlink Wireless, LLC (Nextlink or Company) respectfully requests that the Public Service Commission (Commission) cancel its certificate to provide local exchange and interexchange services in Missouri.<sup>1</sup> The Company further requests that its associated tariff be cancelled as well.

The Commission granted Nextlink a certificate to provide basic local exchange, interexchange and non-switched local exchange and interexchange services in Missouri on February 16, 2016 in Docket No. TO-2006-0267.<sup>1</sup> The Company subsequently determined that its strategic business plans do not include the provision of regulated intrastate services. Nextlink has no customers in Missouri for these regulated services. Accordingly, there are no customers to be notified regarding this request, and the Company's surrender of its authority will have no adverse consequences for consumers in Missouri.

Nextlink understands that formal application to the Commission is not required in order for the Company to surrender its certificate and associated tariff. If the Commission nonetheless determines that further actions are necessary for the Company to surrender its certificate, Nextlink respectfully asks that the Commission advise the Company as to the required further

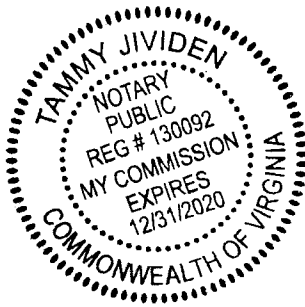


