Seth, FYI, unless you change your position, we will likely be filing a complaint with the PSC for what I consider a failure to directly answer the three questions I raised in my letter to you of July 29.

If we do file, I may be adding a second count alleging that Grain Belt may not refuse to pay for the structure payments and the additional 10% of fee value for easements if the question goes to court in a condemnation proceeding. This position would be based on the Missouri Landowner Protocol, which requires that those payments be made.

Also, I have three questions for you. At this point, how many voluntary easements has Grain Belt acquired for the Missouri right-of-way; how many such easements will Grain Belt need in total for the Missouri portion of the line; and has Grain Belt conducted any wildlife/environmental studies in Caldwell County. If they have, kindly send me a copy of any such studies they have conducted.
