On January 31, 2022, Evergy Missouri Metro and Evergy Missouri West (Evergy) filed an application with supporting testimony seeking the Commission's approval to extend its Missouri Energy Efficiency Investment Act Cycle 3 programs an additional year. Pursuant to Commission Rule 20 CSR 4240-20.094(5)(A)5, parties have 30 days to file any objections to Evergy's application. On February 25, 2022, the Commission's Staff (Staff) filed a timely objection to Evergy's application. Commission Rule 20 CSR 4240-20.094(5)(A)6 provides that if objections to the application are received the Commission shall provide the opportunity for a hearing. Therefore, Staff shall consult with the other parties and submit a proposed procedural schedule.

THE COMMISSION ORDERS THAT:

1. Staff shall file a proposed procedural schedule on behalf of the parties no later than March 17, 2022.

2. This order shall be effective when issued.
