**ORDER TO FILE PROGRAM YEAR 3 EVALUATION, MEASUREMENT,
AND VERIFICATION REPORT**

On February 14, 2023, Evergy Missouri Metro and Evergy Missouri West (Evergy) filed a motion for an extension of time to file its Program Year 3 Evaluation, Measurement, and Verification Reports (PY3 EM&V Reports) from June 30, 2023, to July 31, 2023. The Commission granted that request. Evergy did not file its PY3 EM&V Reports on July 31, 2023. Therefore, the Commission will order Evergy to file its PY3 EM&V Reports and further extend the time for any change requests.

THE COMMISSION ORDERS THAT:

1. Evergy must file its PY3 EM&V Reports no later than August 4, 2023.
2. Any change requests shall be filed no later than 30 days after Evergy files its PY3 EM&V Reports.
3. This order is effective when issued.
