## RESPONSE TO ORDER RELATING TO TRUE-UP HEARING

COMES NOW Summit Natural Gas of Missouri, Inc. ("SNGMO"); for itself and on behalf of the Staff of the Missouri Public Service Commission; the Office of the Public Counsel; Missouri School Boards' Association; Missouri Propane Gas Association; and, Missouri Department of Economic Development – Division of Energy; (collectively the "Parties"), and respectfully states as follows to the Missouri Public Service Commission ("Commission"):

- 1. On August 26, 2014, the Commission issued its Order Relating to True-Up Hearing. Therein, the Commission set a deadline for a motion to cancel the true-up hearing or, in the alternative, a list of issues for that hearing.
- 2. The Partial Stipulation and Agreement As To Energy Efficiency, Weatherization, and Other Matters (Stipulation), filed on August 22, 2014, includes the following provision related to the true-up process:

The Parties agree that a true-up is not necessary in this case and request the Commission to modify its orders to eliminate the true-up requirement and the procedural events associated with the true-up.

3. It is the Parties intention that this provision eliminate the need for any true-up proceeding. Accordingly, if the referenced Stipulation is approved, the Parties request that the true-up hearing and related procedural requirements be canceled.

WHEREFORE, the Parties respectfully request that the Commission consider this response

to satisfy the requirements of the Order Relating to True-Up Hearing.
