**THIRD ORDER GRANTING STAFF’S MOTION FOR AN EXTENSION OF
TIME TO FILE A PROPOSED PROCEDURAL SCHEDULE**

On February 28, 2022, the Commission directed its Staff (Staff) to file a proposed procedural schedule on behalf of the parties no later than March 17, 2022. That deadline was extended to March 24, 2022, and then to April 7, 2022, at Staff’s request. On April 7, 2022, Staff requested a further extension until April 21, 2022. In support of its request Staff offers that settlement discussions continue and Public Counsel, Midwest Energy Consumers Group, and Evergy do not oppose the request. The Commission will grant the extension.

THE COMMISSION ORDERS THAT:

1. Staff’s motion for an extension is granted. Staff shall file a proposed procedural schedule no later than April 21, 2022.
