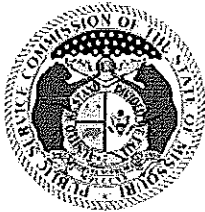
1. The Commission's Data Center shall make the parties to File No. EO-2018-0038 parties to this case.




