On April 12, 2019, Union Electric Company d/b/a Ameren Missouri filed its 2019 Integrated Resource Plan Annual Update Report, as required by the Commission's Electric Utility Resource Planning Rule, 4 CSR 240-22.080(3). Ameren Missouri's update report was filed with both public and confidential versions. Additionally, Ameren Missouri stated that it has set its annual update workshop for April 30, 2019, and that confidential information may be discussed at that workshop.
