## **MOTION FOR CORRECTION**

COMES NOW Ellington Telephone Company ("Ellington") and for its *Motion for Correction* states to the Commission as follows:

- On February 28, 2003, Ellington filed its Application for Approval of a Traffic Termination Agreement.
- 2. On April 9, 2003, the Commission issued an *Order Approving Interconnection Agreement* in this case. The Commission's *Order* refers to the agreement between Ellington and Verizon Wireless as an "Interconnection" Agreement rather than a "Traffic Termination" Agreement.
- 3. Ellington requests that the Commission issue a corrected *Order* with the following changes:
  - (A) The title changed to *Order Approving <u>Traffic Termination</u> Agreement*.
  - (B) The first sentence of the *Order* revised to read as follows: "This order approves the <u>Traffic Termination</u> Agreement executed by the parties and filed by Ellington Telephone Company."
  - (C) The deletion of footnote 1.
  - (D) The fourth sentence of the *Order* changed to read as follows: "The Agreement will cover traffic originated by, and under the responsibility

of one of the parties and terminated to the other party without direct interconnection of the parties' networks."

(E) That the first ordered paragraph on page five of the *Order* be revised to read as follows: "1. That the <u>Traffic Termination</u> Agreement between Ellington Telephone Company and Verizon Wireless, LLC, filed on February 28, 2003, is approved."

WHEREFORE, Ellington respectfully requests the Commission to issue an *Order* that makes the corrections listed above and grants such other relief as is reasonable in the circumstances.
