## ORDER DIRECTING APPLICANTS TO PROVIDE INFORMATION

Issue Date: April 8, 2008 Effective Date: April 8, 2008

On March 12, 2008, the Staff of the Missouri Public Service Commission, the Office of the Public Counsel, and Praxair, Inc., AG Processing, Inc., and the Sedalia Industrial Energy Users' Association filed a Motion for Compliance with Commission Order. The moving parties request that the Commission require Great Plains Energy Incorporated and Kansas City Power & Light Company "to produce all correspondence with ratings agencies that lead KCPL/GPE witnesses Cline and Bassham to represent the positions of the ratings agencies in their testimony; and all spreadsheets with formulas intact that underlie the testimony (including attachments) of Mr. Cline."

Great Plains and KCPL replied to the motion and indicated that they were providing the requested information. Pursuant to the Commission's request, the moving parties answered that all issues had been resolved with the exception of one dollar

amount being redacted from each of two letters from the rating agencies. The movants request the Commission direct Great Plains and KCPL to provide that information.

The Commission finds that the information requested by the movants is relevant to the testimony of Mr. Cline and Mr. Bassham prefiled by Great Plains and KCPL. It is obvious from that testimony that the information received from the rating agencies was relied upon in formulating Mr. Cline and Mr. Bassham's testimony, and therefore, the Commission shall require its production.

## IT IS ORDERED THAT:

- 1. No later than April 11, 2008, Great Plains Energy Incorporated and Kansas City Power & Light Company shall produce copies of the rating agency letters without information redacted. Production of these documents shall be to the requesting parties and any other party as required under the discovery procedures set out in this case.
  - 2. This order shall become effective on April 8, 2008.
