Subject: SB 376 Rulemaking Workshop Number 3

SB 376 Rulemaking Workshop Number 3 will be held on Friday June 11, 2010, 9:00 AM – 5:00 PM in Room 450 (Ballroom) of the Governor Office Building at 200 Madison Street, Jefferson City, MO 65102.

Attached are the current drafts of the SB 376 rules and other materials for the workshop discussion on Friday. The redline version of the draft SB 376 rules are still incomplete in some areas including some incomplete definitions. I apologize for not having all drafts completed, but wanted to get what I have to you at this time, so you have an opportunity to prepare for the workshop on Friday.

The attached draft rules are not the Staff's draft rules, but rather draft rules developed after considering all of the input received from the SB 376 rulemaking workshop participants during and since the SB 376 rulemaking workshop on May 17 – 18, 2010.

There are four draft rules for SB 376 which follow the convention used for the existing Electric Utility Fuel and Purchased Power Cost Recovery Mechanism rules (4 CSR 240-3.161 and 4 CSR 240-20.090) and for the existing Electric Utility Environmental Cost Recovery Mechanisms rules (4 CSR 240-3.162 and 4 CSR 240-20.091). We can discuss the overall approach to the rules in more detail on Friday.

The workshop on June 11, 2010 will be webcast on the Missouri Public Service Commission website www.psc.mo.gov.
