ORDER SETTING PROCEDURAL SCHEDULE

Issue Date: February 27, 2019

Effective Date: February 27, 2019

On January 22, 2019, the Commission issued an *Order Directing Filing of Available Dates for Evidentiary Hearing*. This order directed the parties, no later than January 29, 2019, to file the dates when they will be available for an evidentiary hearing in Caruthersville, Missouri, during the months of March and April of 2019. Staff and the Company responded. Ms. Beatty did not. The Commission will set a procedural schedule consistent with the responses received.

THE COMMISSION ORDERS THAT:

1. The procedural schedule due-dates are as follows:

Pre-filed Testimony from Staff and any other Party wishing to file such	April 9, 2019
List of Issues, List of Witnesses, and Order of Cross-Examination	April 16, 2019

2. The evidentiary hearing will occur on April 23, 2019, at 9:30 a.m. The hearing will be held in the conference room of the Caruthersville Library at 707 West 13th Street, in Caruthersville, Missouri, a facility that meets the accessibility standards of the Americans with Disabilities Act (ADA). Any person who needs additional accommodations to participate in the hearing should call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the hearing.

3. All parties *shall* pre-file their testimony. If Ms. Beatty fails to pre-file direct testimony, the Company shall pre-file rebuttal testimony responsive to the Complaint. Any issue not listed in the List of Issues and any witness not listed in the List of Witnesses will not be considered by the Commission. Staff, in consultation with all parties, shall take the lead in preparing and filing the List of Issues, List of Witnesses and Order of Cross-Examination.

4. The Data Center of the Missouri Public Service Commission shall mail this Order to Jill C. Beatty at P.O. Box 609, Caruthersville, Missouri 63830, by certified mail, return receipt requested.

5. This order shall be effective when issued.




