NOTICE OF DEFICIENCY IN SECOND APPLICATION TO INTERVENE

Issue Date: May 25, 2023

On May 23, 2023,¹ Brett Felber filed a complaint with the Missouri Public Service Commission against Union Electric Company d/b/a Ameren Missouri. On May 30, an application to intervene was filed on behalf of Lisa Lambert. It appears Ms. Lambert is seeking to intervene and represent herself, which is allowed.²

Commission Rule 4240-2.075 sets forth the requirements of applications to intervention. The rule requires that an application to intervene include the street and mailing address for the proposed intervenor. Ms. Lambert’s application to intervene is deficient in this regard.

² A prior application to intervene was filed by Ms. Lambert on behalf of two corporations, Capital Property Investors LLC and Dividend Park Property Investors LLC. That application was deemed deficient as corporations must have legal counsel to represent them.

Commission Rule 4240-2.075 also requires a statement of the proposed intervenor's interest and reasons why the intervention is sought. Ms. Lambert's application to intervene is deficient in this regard.

Therefore, Ms. Lambert's filing is deficient and the Commission cannot take action on her motion to intervene until this deficiency is corrected. Ms. Lambert may submit an amended application to intervene.
