NOTICE OF AMENDED COMPLAINT

On May 23, 2023,¹ Brett Felber filed a complaint with the Missouri Public Service Commission against Union Electric Company d/b/a Ameren Missouri. Ameren Missouri's answer is not due until June 26. A prehearing conference to discuss the next steps in this matter is scheduled for June 16.

On June 14, Mr. Felber submitted a pleading alleging an additional complaint (June 14 Complaint) and requesting that the Commission assign the June 14 Complaint as a new complaint casefile. The Commission sees that the June 14 Complaint may be related to Mr. Felber's underlying complaint, and thus will not establish a new casefile. However, the Commission will consider Mr. Felber's request for a new casefile as a motion to amend his original complaint to add this allegation.

As Ameren Missouri's answer to Mr. Felber is not due until June 26, the Commission will direct Ameren Missouri to also answer the June 14 Complaint no later than June 26.

THE COMMISSION ORDERS THAT:

1. Ameren Missouri shall file its answer to Mr. Felber's June 14 Complaint filing, or a request for additional time, no later than June 26.
2. Mr. Felber's request to open a new complaint casefile is denied.
3. This order shall be effective when issued.
