**ORDER SHORTENING TIME FOR RESPONSES  
TO SECOND EMERGENCY RESTORATION REQUEST**

Issue Date: June 1, 2023

Effective Date: June 1, 2023

On May 23, 2023,<sup>1</sup> Brett Felber filed a complaint with the Missouri Public Service Commission against Union Electric Company d/b/a Ameren Missouri. On May 25, Mr. Felber filed his *Emergency Petition* (Petition) seeking restoration of electrical services immediately. The Commission ordered responses to the Petition be filed no later than June 1.

On May 30, Mr. Felber filed his *Emergency Restoration Request* (Request) again seeking immediate restoration of service. The Commission will shorten the standard 10-day time frame for parties to respond to the Request.

1. Ameren Missouri shall file a response to the *Emergency Restoration Request* no later than June 7, 2023.
2. No other party is required to respond, but any party that wishes to do so shall file such response no later than June 7, 2023.
