**MAWC AGREEMENT WITH STAFF RECOMMENDATION**

COMES NOW Missouri-American Water Company (MAWC) and, in response to the Staff Recommendation, states the following to the Missouri Public Service Commission (Commission):


1. On October 29, 2014, MAWC filed an Application requesting a certificate of convenience and necessity associated with a subdivision in Cole County, Missouri.
2. On February 23, 2015, the Staff of the Commission (Staff) filed its Staff Recommendation and an associated Memorandum.
3. MAWC has reviewed the Staff Recommendation and does not object to the conditions proposed by the Staff. Accordingly, MAWC asks that the Commission approve the Application, subject to Staff's proposed conditions.

**WHEREFORE**, MAWC respectfully requests the Commission grant it permission, approval and a Certificate of Convenience and Necessity authorizing MAWC to:

- a) install, acquire, build, construct, own, operate, control, manage and maintain a water system for the public within the area referred to in the Application;
- b) acquire the identified assets of RMB, Inc.; and,

c) take such other actions as may be deemed necessary and appropriate to accomplish the purposes of the Application.
