INFORMATIONAL FILING

COMES NOW Cintex Wireless, LLC (“Cintex” of the “Company”) and, pursuant to 4 CSR 240-3.570(3)(D), hereby files the following description of its service offerings:

1. On March 14, 2012, Cintex filed its Revised Compliance Plan with the Federal Communications Commission (“FCC”). A copy of the Revised Compliance Plan as filed with the FCC is attached hereto as **Attachment I**. Cintex certifies that its voice telephony services comply with the requirements of 47 C.F.R. § 54.101.

2. Detailed information regarding Cintex’s terms and conditions of service is set forth in Exhibit 2 to the attached Compliance Plan, and also can be found at <http://cintexwireless.com/terms-conditions/>.

3. As described in the attached Compliance Plan, Cintex offers each eligible subscriber ninety (90) free anytime local and long distance minutes per month. Text messaging is available at a rate of one text per voice minute. Any unused minutes roll over from month-to-month. Cintex does not charge a monthly recurring fee; the Company’s service is a strictly pay-as-you-go service.

4. In the event that a subscribed uses all of his or her minutes, the subscriber may purchase additional airtime, or “top-up” minutes, as described in the attached Compliance Plan.

5. Wireless handsets are provided to qualifying Lifeline subscribers free of charge. Lifeline service includes caller ID, call waiting, call forwarding, 3-way calling, and voicemail.

Calls to 911 emergency services are free, regardless of service activation or availability of minutes.

WHEREFORE, Cintex Wireless, LLC hereby files the foregoing description of its service offerings, pursuant to 4 CSR 240-3.570(3)(D), and attaches its Compliance Plan.
