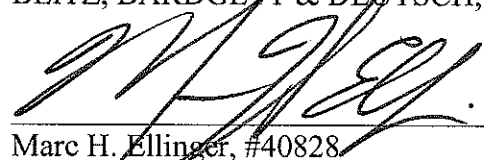
**INTERVENOR CITY OF JOPLIN'S

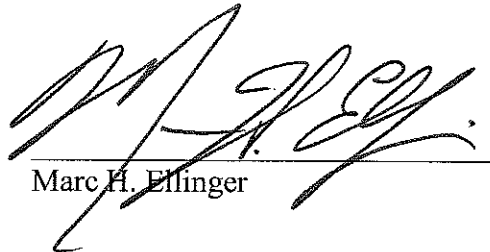
