- 4 EO-2006-0141 is in the matter of the application of The
- 5 Empire District Electric Company for authority to transfer
- 6 functional control of certain transmission assets to the
- 7 Southwest Power Pool, Incorporated. EO-2006-0142 is in
- 8 the matter of the application of Kansas City Power & Light
- 9 Company for authority to transfer functional control of
- 10 certain transmission assets to the Southwest Power Pool,

- 12 My name is Kennard Jones. I'm the
- 13 Presiding Judge in these cases. As many of you here know,
- 14 all of the parties to both these cases are pretty much the

- 18 Empire's application. Let's see. Southwest Power Pool,
- 19 Aquila and Midwest Independent Transmission System
- 20 Operator have all been granted intervention. Kansas City
- 21 Power & Light has an application to intervene. Are there
- 22 any objections to that application?
- 23 (No response.)
- 24 JUDGE JONES: Seeing none, Kansas City
- 25 Power & Light then is granted intervention. I'll issue a

- With regard to EO-2006-0142, Empire has
- 3 filed an application to intervene. Are there any
- 4 objections to that application?
