MOTION FOR EXTENSION OF TIME TO FILE STATEMENTS OF POSITION

COMES NOW Missouri-American Water Company (MAWC or Company), and for its Motion for Extension of Time to File Statements of Position, states as follows to the Missouri Public Service Commission (Commission):

1. The joint list of issues, order of witnesses, order of cross examination and order of opening statements document was originally to be filed May 10, 2010, and the parties' statements of position were to be filed May 12, 2010.

2. The Staff previously filed a motion, and was granted, an extension until May 11, 2010, for the filing of the joint list of issues, et al. This extension was necessary to make sure all parties' comments and edits were made to that document.


3. The Joint List of Issues, Order of Witnesses, Order of Cross Examination and Order of Opening Statements was filed late in the day on May 11, 2010. In order to address the issues as they now appear in the Joint List of Issues, MAWC requests that the Commission grant the parties a one day extension, until May 13, 2010, for the filing of the parties' statements of position.

4. Counsel for MAWC has communicated MAWC's intent to request this extension to counsel for the other parties. Counsel for Staff, OPC, MEG, MIEC, Triumph, St. Joseph Water Districts, City of Warrensburg, City of Riverside, City of

Joplin, MSD and AGP have affirmatively stated that they do not object to the requested extension. No other party has expressed an objection.

WHEREFORE, MAWC respectfully requests that the Commission grant the parties a one day extension, until May 13, 2010, for the filing of the parties' statements of position.
