**JOINT MOTION FOR WAIVER OF COMMISSION ORDER TO PROVIDE  
CUSTOMER NOTIFICATION**

COME NOW, The Gascosage Electric Cooperative and Three Rivers Electric Cooperative, by and through their attorneys of record, and hereby file their Joint Motion for Waiver of Commission Order to provide customer notification as part of their joint application for approval of a territorial agreement. As grounds therefore, petitioner states as follows:

1. Gascosage Electric Cooperative and Three Rivers Electric Cooperative filed their joint application seeking approval of their territorial agreement on November 7, 2003.
2. On November 14, 2003, the Commission issued its Order and Notice, and Order Setting Prehearing Conference and Requiring Proposed Procedural Schedule. Pursuant to that Order, the joint applicants were ordered to provide notice to their customers and file proof thereof in this case.
3. The territorial agreement provided by the joint applicants establishes their respective exclusive service territories, but does not contain a customer exchange. The territorial agreement will have no impact on the rates or services provided to each cooperatives' respective customers.

4. Customer notification is typically limited to circumstances wherein the customer will be affected. The territorial agreement filed by Three Rivers and Gascosage Electric Cooperatives does not contemplate a customer exchange, and will have no impact on either cooperatives' existing customers. The joint applicant's customers will not gain any additional benefit by such notification, and such notification may potentially cause customer confusion.

WHEREFORE, the joint applicants, Gascosage Electric Cooperative and Three Rivers Electric Cooperative, hereby request a waiver of the Commission's Order issued on November 14, 2003, requiring that the joint applicants each provide notice to their customers and file proof thereof in this case.


