On September 6, 2007, The Empire District Electric Company filed its Integrated Resource Plan – frequently referred to as an IRP - as required by Commission Rule 4 CSR 240 - Chapter 22. The purpose of the IRP is to ensure that investor-owned electric utilities, such as Empire, consider all options, including demand side efficiency and energy management measures, to provide safe, reliable, and efficient electric service to the public at reasonable rates, in a manner that serves the public interest.

As required by 4 CSR 240-22.080(4), the Commission will give notice of Empire's filing to potentially interested parties, will set a date for the filing of requests to intervene, and will schedule a prehearing conference.

IT IS ORDERED THAT:

1. The Missouri Public Service Commission's Data Center shall mail a copy of this notice to each of the parties in The Empire District Electric Company's most recent rate case, ER-2006-0314.

2. The Commission's Public Information Office shall make notice of this order available to the media serving The Empire District Electric Company's service area and to the members of the General Assembly representing the Empire District Electric Company's service area.

3. Any proper person wishing to intervene in this matter shall file an application to intervene no later than October 3, 2007. Such applications shall be filed with:
