ORDER AND NOTICE

On June 27, 2008, Grundy Electric Cooperative, Inc. and the City of Trenton, Missouri filed a Joint Application. The parties ask that the Commission find that the proposed territorial agreement is not detrimental to the public interest and to approve the agreement.

Applicants have mutually agreed to displace competition between themselves as allowed by law and have set out the terms of their agreement. The agreement is attached to the application and marked as Appendix A. No other municipal electric supply systems and investor-owned electric utilities operate within the area covered by the Agreement.

The Commission must rule on the application within 120 days of June 27, 2008 (October 25, 2008), unless otherwise ordered by the Commission for good cause shown. The Commission has determined that the information officer of the Commission will make notice of this application available to the newspapers and other media serving Grundy County, Missouri, and to all members of the Missouri General

Assembly representing that county. Further, the Data Center of the Commission shall serve a copy of this order on the County Commissioners of Grundy County.

Proper persons wishing to intervene shall have 20 days from the date of this order to file an application to intervene with the Secretary of the Commission and shall send a copy of the application to intervene to all parties as directed below.

The requirement of a hearing has been fulfilled when all those having a desire to be heard are offered an opportunity to be heard. If no proper party is granted intervention and neither the Commission's Staff nor the Office of the Public Counsel requests a hearing, the Commission may determine that a hearing is not necessary.

IT IS ORDERED THAT:

- The Data Center shall send a copy of this order to the County Commissioners of Grundy County, Missouri.
- 2. The Information Officer of the Missouri Public Service Commission shall send notice to the members of the General Assembly representing the Applicants' service areas and to the newspapers and other media that serve Applicants' service areas.
