STAFF'S REVIEW OF INFRASTRUCTURE STANDARDS COMPLIANCE PLAN

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and states:

1. On July 2, 2008, Union Electric Company d/b/a AmerenUE (Company) filed a document and fifteen appendices outlining its inspection cycles for various components of its transmission and distribution systems.

2. On December 23, 2008, the Company filed a document and an additional four appendices outlining the inspection cycles for additional system components.

3. On January 2, 2009 the Commission ordered Staff to set a date by which Staff would file its report of its review of the Company's filing of a Compliance Plan concerning Infrastructure Standards pursuant to Missouri Public Service Commission Rule 4 CSR 240-23.020.

4. Commission Rule 4 CSR 240-23.020(3)(B) provides:

Each electrical corporation subject to this rule shall file at the commission by no later than July 1, 2008, compliance plans for the inspections and record keeping required by this rule, with verification by affidavit of an officer who has knowledge of the matters stated therein. These compliance plans shall include the proposed forms and formats for annual reports and source records, as well as the electrical corporation's plans for the types of inspections and equipment to be inspected during July 1 through December 31, 2008 and the coming calendar year. The electrical corporation's compliance plans shall include a projected schedule for completing a full cycle for each infrastructure classification shown in the attached table titled "Electrical Corporation System Inspection Cycles (Maximum Intervals in Years)."

5. Commission Rule 4 CSR 240-23.020(3)(G) provides:

Commission staff shall review each electrical corporation's annual report and may inspect and verify that the electrical corporation is in compliance with this rule.

6. Pursuant to 4 CSR 240-23.020(3)(G), in its attached Report, attached hereto and incorporated by reference as Appendix A, the Staff verifies that the Company's filings are in compliance with 4 CSR 240-23.020(3)(B).

WHEREFORE, the Staff submits its Report verifying Union Electric Company d/b/a AmerenUE's compliance with the filing requirements set forth in 4 CSR 240-23.020(3)(B).
