ORDER SUSPENDING TARIFF

On June 8, 2009, the Office of the Public Counsel filed a motion asking the Commission to suspend a tariff revision filed by Union Electric Company, d/b/a AmerenUE. AmerenUE's proposed tariff revision carries an effective date of June 13. AmerenUE responded to Public Counsel's motion on June 9.

AmerenUE indicates it is willing to have the Commission suspend its tariff until July 8 to allow more time for Public Counsel and the Commission to further review that tariff. However, AmerenUE would object to a longer suspension because further delay would prevent the tariff revision from taking effect for this summer's peak electric demand period. AmerenUE expresses confidence that it will be able to satisfy Public Counsel's concerns about the tariff, but asks the Commission to schedule a hearing on the tariff for June 26 so that the Commission would be able to rule on any continuing objection to the tariff before the summer peak electric usage season.

Staff also responded to Public Counsel's motion on June 9. Staff shares some of Public Counsel's concerns about AmerenUE's tariff and asks the Commission to suspend the tariff to allow more time for the Commission to consider the tariff.

Because AmerenUE's tariff revision will otherwise go into effect before the Commission has an opportunity to fully evaluate Public Counsel's concerns, the Commission will suspend those tariff revisions until July 9, as permitted by Section 393.150, RSMo 2000. The Commission will also schedule a hearing on AmerenUE's tariff for June 26.

THE COMMISSION ORDERS THAT:

1. The tariff sheets issued on May 14, 2009, by Union Electric Company, d/b/a AmerenUE, and assigned Tariff No. JE-2009-0804, are suspended beyond June 13, 2009, to July 9, 2009, or until otherwise ordered by this Commission. The tariff sheets suspended are:
