### **ORDER APPROVING TARIFF FILINGS IN COMPLIANCE WITH** **COMMISSION ORDER**

Issue Date: February 22, 2007

Effective Date: March 7, 2007

On January 11, 2007,<sup>1</sup> the Missouri Public Service Commission issued its Report and Order in this matter approving The Empire District Electric Company's ("Empire") and White River Valley Electric Cooperative's territorial agreement. In the Report and Order, the Commission directed Empire to file revised tariff sheets to add the map and legal description of the exclusive territory it obtained from the Fifth Territorial Agreement between White River Valley Electric Cooperative and The Empire District Electric Company, as amended by the First Amendment to the Fifth Territorial Agreement, to those it has from prior Commission approved territorial agreements. On February 5, Empire filed its revised tariff sheets.

On February 6, the Commission directed its Staff to file a recommendation advising the Commission whether the revised tariff sheets were in compliance with the Commission's Report and Order. On February 21, Staff filed its recommendation and

verified memorandum. Staff finds the tariff sheets accurately reflect the changes to Empire's service area as a result of the approved territorial agreement. Staff finds the tariff sheets to be in compliance with the Commission's Report and Order and recommends that the Commission approve the submitted tariff, or to allow it to go into operation by law on its effective date of March 7, 2007.

**IT IS ORDERED THAT:**

1. The tariff sheets filed by The Empire District Electric Company on February 5, 2007, pursuant to the Commission's January 11, 2007 Report and Order, assigned Tariff No. YE-2007-0547, are approved to become effective on March 7, 2007.
