SECOND REQUEST FOR ADDITIONAL TIME

COMES NOW Spire Missouri Inc., (“Spire”) by and through counsel and files this Request for Additional Time and respectfully states as follows in support:

1. On December 23, 2021, Spire filed its Verified Application to Change its Infrastructure Surcharge in its Spire Missouri East and West Service and Request for Waiver from 60 Day Notice Rule (“Application”).
2. On December 23, 2021, the Commission issued its order and directed Staff to file its recommendation regarding the Application by March 23, 2022, and no later than March 23, 2022, the Office of the Public Counsel (“OPC”) and any other party shall file any objections or hearing requests. The Commission also ordered Spire Missouri to respond to Staff’s recommendation and any other objections or recommendations no later than March 30, 2022.
3. On March 23, 2021, Staff filed its Staff Recommendation.
4. Spire previously asked for additional time until April 7, 2022 to allow for discussion with OPC and Staff. Those parties have met and continue to discuss Staff’s recommendation and are hopeful a resolution may be reached.
5. The Commission granted that request on March 29, 2022.

6. Spire requests additional time, until Monday, April 11, 2022, to file a response to Staff's recommendation or a stipulation and agreement to allow the parties additional time to discuss and work toward an agreement.

7. Spire counsel has spoken to counsel for Staff and OPC and they do not object to this pleading.

Wherefore, Spire hereby requests that the Commission grant the parties additional time until April 11, 2022, to file responses or a stipulation and agreement in this matter.
