ORDER GRANTING MOTION FOR EXPEDITED TREATMENT
AND APPROVING TARIFF SHEETS

Issue Date: September 13, 2007

Effective Date: September 17, 2007

On August 27, 2007, Aquila, Inc., d/b/a Aquila Networks, filed tariff sheets designed to implement a Residential Lighting Program in accordance with the agreement approved by the Commission in Case No. ER-2007-0004. The tariff sheets bear an effective date of September 27, 2007, however, Aquila filed a Motion for Expedited Treatment requesting that the tariff sheets become effective on September 17, 2007. The expedited effective date will allow Aquila sufficient time to enter into its agreement with the Midwest Energy Efficiency Alliance.

The Commission issued an order directing the Staff of the Missouri Public Service Commission to file a response to the motion and a recommendation. Staff filed its recommendation on September 7, 2007. Staff stated that in its opinion the tariff sheets comply with the agreement in ER-2007-0004 in which Aquila agreed to implement cost-effective demand side management programs as determined in Case No. EO-2007-0298, Aquila's Electric Resource Plan. No other responses were filed.

The Commission has reviewed the Motion for Expedited Treatment, the tariff filing, and the Staff Recommendation which are hereby admitted into evidence. The Commission finds that the tariff complies with the Stipulation and Agreement approved in Case No. ER-2007-0004, and shall approve the tariff. In addition, the Commission finds that good cause exists to allow the tariff to become effective on less than thirty-days notice so that Aquila may have sufficient time to enter into an agreement and implement the program.

IT IS ORDERED THAT:

1. The Motion for Expedited Treatment is granted.
2. The following tariff sheets filed by Aquila, Inc., d/b/a Aquila Networks, on August 27, 2007, and designated Tariff File No. JE-2008-0134, is approved to become effective on September 17, 2007:
